With these words, I am pleased to share with you the outcome of efforts by entire executive committee during this lockdown period of May, 2020.

BAR submitted many representations through Email and conducted meeting personally in the chamber of the Commissioner DGST and T&T. All issues like new registrations, cancellations, reviews, objections, and refunds were discussed in detail. The office of the Commissioner issued a detailed circular extending all limitations up to 30/06/2020 in line with Hon'ble Supreme Court order and provided temporary arrangements for urgent issues by appointing nodal officers for each zone. The worthy commissioner appraised that most of the staff was on Covid-19 duty and now started resuming office. He further assured the proper functioning of the Department very shortly.

During this month, STBA organized three study circles meeting through webinars. The first was on the Topic "Penalty u/s. 271 AAD on case study basis & recent Hon'ble Apex Court judicial pronouncements with the scope of Section 143(1) under the Income Tax Act" by Advocate Sh.
