Respected members, undersigned received many complaints from our BAR members that some past contractual DEOs are still working informally at the behest of the Assistant Commissioner and GSTOs. BAR raised this issue very seriously with Commissioner DGST and I am happy that he took an urgent note of it and after inspection from senior officers, issued a circular prohibiting the presence of all such unauthorized persons.
